- -outlined the purpose/goals: ID high users of law enforcement and reduce their usage

develop partnerships with services and agencies

provide wrap around support

build relationships and collaboration with support systems

investigate gaps and fix (ex. now garner release of info from "consumers" so can quickly share needed info)

support police officers-provide background information and where to go for info and help when dealing with a consumer.

The officers feel the program has been very successful:

50% of contacts resulted in consumer connection to new resource not just crisis intervention but collaborative problem solving with agencies

Whitney says successes are consumer successes!
