**For those interested Karen Kuhlman's Lighthouse Overview is summarized here:**

History and purpose of Lighthouse: offering non-medical, overnight respite to those experiencing overwhelming mental health and substance use related crises or any other emotionally distressing challenges (1-7 nights). Operating 24 hour/7 days a week warm line support (non-crisis phone support) with access to 1:1 peer support, individually and as a group to develop connections into community, resources, natural support, and activities. Staff includes 2 certified peer specialists with documented history of addiction/abuse. Occasionally guests are asked to leave when violating house rules but alternate housing is arranged.
