Meeting Purpose and Content

A number of zoning requests were addressed and approved:

- converting first floor retail/commercial to residential in the fairly new development 7th & Farnum
- alley vacation by Mayo
- conversion of single-family to Traditional Neighborhood Development for development of townhouses on 10th and Denton
- transfer from Local Business to Planned Development for the former Kmart site
- allowed an exception for addition parking stall requirements

The commissioners received a report on the launching of the city's Comprehensive Plan process. City planner Tim Acklin introduced Mary Walker Kramer, the city's project writing manager from Graef Planning & Urban Design in Milwaukee and showed a kickoff video from the comp plan interactive website.

- ☑ Meeting content was limited to only noticed agenda items, including business discussed in closed session.
- ⊠ A record of motions, seconds, and roll-call votes from the meeting will be (was?) created and preserved.

Good Practice for Public Accessibility Checklist

oxtimes The meeting was available to view or listen to on-line.
oxtimes Copies of the agenda and handouts were available to the public. Important information was available for viewing via handouts, web links, or projector.
\square Roll call was conducted, and the public could identify members who were present or absent
\square Speakers were identified and could be easily heard.
oxtimes The public was given an opportunity to speak at the meeting.
imes Minutes and/or a recording of the meeting will be made available to the public.
